Auditor General's report

Audit opinion - Qualified

Except for the matters reported in my Basis for Qualification below, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's/Committee's governance arrangements; and
- that the Council/Committee does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of qualification

In my opinion, the Council's governance statement is not consistent with the actual arrangements in place during the year. The Council's internal auditor drew the Council's attention to deficiencies in internal control including a failure to comply with standing orders, missing accounting records and a failure to carry out a risk assessment. These deficiencies have not been reflected in the Annual Governance Statement.

Other matters arising and recommendations

Asset register

- We draw the Council's attention to the recommendations made by the Council's internal auditor regarding the asset register. It is important that the Council maintains an up to date register of assets held to ensure they are secure and properly managed.

There are no further matters I wish to draw to the Council's attention.
