**94 APOLOGIES FOR ABSENCE**

Apologies for absence were submitted on behalf of Councillors David Edwards and Bernie McCann.

**95 POLICING IN THE COMMUNITY**

In the absence of PCSOs Becky Stallard and Catherine Griffiths-Hughes, the Crime Reports for December 2012 were presented by PCSO Mike Simister.

Referring to the report for Gwersyllt East/South, a Member said that it would be helpful if in future reports to the Council the PCSOs could indicate whether any offences were repeat offences.

Concerns were expressed about the number of offences for violence with PCSO Simister indicating that it was likely that most of these were alcohol related.

In response to a Member's query about recent burglaries in Gwersyllt West, PCSO Simister said that he would ask PCSO Becky Stallard to provide more information.

In conclusion, Members said that they were pleased with the new format of the monthly Crime Reports and, commenting on the recent departure of PCSO Phil Jones, asked that a letter be sent to PCSO Jones on the Council's behalf thanking him for all his work in the community and extending Members' best wishes to him.

PCSO Simister was thanked for his attendance.

**96 MINUTES**

**RESOLVED – That the Minutes of the Meeting of the Council held on 19 December 2012 be received and confirmed as a correct record.**

**Matters arising –**

**Minute 82 – Community Centres – Budget Reductions 2013/14** - The Vice-Chair reported that earlier today he and the Clerk and Financial Officer had met Dylan Hughes and colleagues from Wrexham County Borough Council, to discuss a possible way forward with respect to the future use of the Sydalit Community Council. He advised that it had been agreed to recommend to the

Management Committee of the Gwersyllt Resource Centre that the Sydalit Community Centre be managed and administered from the Resource Centre on an interim basis as from 1 April 2013, pending a firm decision on its future use.

The matter was noted.

(In accordance with the Council's Code of Conduct for Members, Councillor David Griffiths declared a personal, but non-prejudicial interest in this matter (in his capacity as the County Borough Council's Lead Member for this purpose).

**Minute 84 – Wrexham Local Development Plan - Call for Sites – Land at the Top End of First Avenue, Gwersyllt, near Beech Street and Ash Close** – Referring to the decision contained in Minute 84, a Member advised that it was not clear who owned this site though it was understood that the County Borough Council maintained it.

**Minute 93 – Policing in the Community** – The Clerk and Financial Officer reported that he had received a reply from the Police and Crime Commissioner thanking the Council for its views and advising that he would welcome the Council's comments on what kind of policing service it expects from North Wales Police. In addition, the Police and Crime Commissioner's reply referred to the proposed development of a draft Police and Crime Plan.

**RESOLVED – That this matter be discussed further at the next meeting of the Council and that, in the meantime, enquiries be made to ascertain whether town and community councils will be consulted for their views on the draft Plan prior to its publication.**

#### **97 UPDATING THE COUNCIL'S WEBSITE**

The Chair reported an apology for absence from Michele Walker, designer of the Council's website, and so it was agreed that this item be deferred until the next meeting of the Council.

#### **98 ADDITIONAL LICENSING OF HOUSES IN MULTIPLE OCCUPATION (HMOs)**

The Clerk and Financial Officer submitted a letter from Housing Standards and Strategy Unit, Wrexham County Borough Council, advising that one property in Gwersyllt – 49 Top Farm Road, Rhosrobin – had been issued with a HMO licence and asking that if Members were aware of any other HMOs in the area they should let the County Borough Council know.

Commenting on the matter, the Clerk and Financial Officer explained what an HMO was and drew attention to the fact that under the provisions of the Housing Act 2004 a person having control of or managing an unlicensed HMO was liable on summary conviction to a fine not exceeding £20,000.

**RESOLVED – That if Members become aware of any other HMOs in Gwersyllt they should advise the Clerk and Financial Officer accordingly so that he can report the matter to the Housing Standards and Strategy Unit.**

#### **99 PUBLIC RIGHTS OF WAY NETWORK**

Members considered a letter from Mr. Steve Tilston, Ramblers' Footpath Secretary for the County Borough of Wrexham, about the importance of the public rights of way network and offering to attend a future meeting of the Council to talk about the work being done to keep the network open and in good order.

**RESOLVED – That Mr. Tilston be invited to attend a future meeting of the Council.**

### **100 REFURBISHMENT OF BRADLEY VILLAGE HALL**

The Clerk and Financial Officer submitted a letter from Vervaine Edwards, Secretary, Bradley Village Hall, thanking the Council for its generous grant towards the refurbishment of the Village Hall and extending an invitation for Members to visit the Hall to view the improvements.

It was noted that visits could be arranged via the Village Hall's Secretary or Chairperson (Councillor David Griffiths).




